1. Objectives

To provide guidelines and identify local community based organisations eligible to receive Council financial assistance in the form of an annual donation payment towards their rates and charges, made in recognition of the important services and/or activities that the organisation provides to support shire residents.

2. Scope

This policy covers annual Council donation payments towards relevant rates and charges that are the responsibility of eligible organisations to pay.

This policy is produced by the Corporate and Community Services Directorate with the Finance Branch being responsible for the operation and updating of this policy.

This policy document replaces any previous rates and charges donation policy.

3. Definitions

Policy acronym	Definition
Donation	A grant from Council to an organisation or group and includes 'financial assistance', 'in-kind assistance', 'sponsorship' and 'waiving of fees and charges'.
LGA	Local Government Act 1993
Section 356	Refers to Section 356 of the NSW Local Government Act 1993 which allows Council to financially assist others, by resolution of Council, to contribute money or otherwise grant financial assistance to persons for the purpose of exercising its functions.
Not-for-profit	 The organisation must meet the following guidelines: Not-for-profit incorporated community organisation, with a certificate of incorporation to be provided: OR Registered as an income tax exempt charity (ITEC) with the ATO, with evidence to be provided.
Rates, charges and charges	Relevant rates and charges are levied on properties annually by Council to fund the provision of services. Details of rates and charges are contained within Councils Statement of Revenue Policy which is adopted by Council on an annual basis.



4. Statement

Council's will make an annual donation towards an eligible organisation's (part 4.2) rates, charges and fees (part 4.3) in the form of a payment to the rates and charges account.

The amount of the donation will be displayed on the annual Rates and Charges Notice issued in July.

Any changes to the list of organisations/properties eligible for a donation must be approved by Council.

All donations will be advertised annually in accordance with Section 356 of the LGA and will be recorded in Council's Annual Report.

4.1 Eligibility Criteria

To be eligible for an annual rates and charges donation under this policy, all of the following criteria must be met:

- The organisation must be not-for-profit and/or provide a charitable service.
- The property occupied by the organisation must be integral to the organisation's provision of services.
- The organisation must not be significantly funded from other revenue sources.
- The services and/or activities provided by the organisation must benefit the local community.
- The organisation must not qualify for a rating exemption under sections 555 or 556 of the LGA.
- The organisation can be defined as one of the following organisation types:
 - Community preschool
 - Community based Hall or Community Centre
 - Surf Life Saving Club
 - Scouts or Girl Guides
 - Historical Society
 - Community Garden
 - Showgrounds
 - Other charitable organisations approved by Council for inclusion

4.3 Types and Percentage of Rates and Charges to be Donated

Each rating year Council will donate (as a payment to the rates account) -100% of the following rates, annual charges and fees levied on each property identified as eligible to receive a donation under this policy:

- Ordinary land rate
- Water access charge
- Wastewater (sewer) access charge
- Stormwater management charge
- On-site sewage management fee (OSMS)

Council will not donate user based charges such as water usage charges, wastewater (sewer) usage charges, waste bin collection service charges (including the Waste Operations Charge) and volumetric liquid trade waste charges.

5. Legislative and strategic context

This policy provides the framework under which Council will make community donations. Section 356 of the LGA prescribes the requirements of provide financial assistance to persons/organisations for the purpose of exercising their functions.

This policy support Community Objective 2.2 within Council's Community Strategic Plan 2028 being: "We cultivate and celebrate our diverse cultures, lifestyle and sense of community" by supporting access to a wide range of services and activities that contribute to the wellbeing of all members of the Byron Shire community".



6. Sustainability

6.1. Social

This policy assists not-for-profit community based organisations deliver valuable services to the general community.

6.2. Economic

Council provides the assistance outlined in this policy to contribute to the economic sustainability of organisations to assist them in providing valuable services to Byron Shire residents.

6.3. Governance

Organisations will need to provide evidence of their eligibility upon Council request to continue receiving financial support under this policy.

All donations will be advertised annually in accordance with Section 356 of the Local Government Act. All donations will be recorded in the Annual Report as Section 356 Donations.
