

# Waste disposal vouchers for tenants

Each household gets **TWO** waste disposal vouchers, to the value of \$50 each, for the 2024-2025 financial year. Tenants can use the attached form to apply for vouchers.

You must get approval from your landlord or Real Estate Agent before applying. You must apply separately for each voucher/visit.

To help reduce the amount of waste going to landfill, please consider if your unwanted items can be **rehomed, resold, repaired or repurposed** before disposing of them.

## What waste can vouchers be used for?

Accepted for vouchers	<u>Not</u> accepted for vouchers
Furniture and household items	Fridges
Mattresses, bed bases and carpet	Industrial/commercial waste
Garden waste	Tyres
Renovation waste (non-commercial) eg. bricks and concrete, timber, plasterboard	Liquids
Mixed household waste	Asbestos (not accepted at facility)

## FREE disposal at any time

- ✓ Quality second-hand items can be dropped at 'The Re-Market' (Tip Shop)
- ✓ Electronic waste (TVs, computers, appliances)
- ✓ **Problem wastes** such as - handheld batteries and lead-acid (car) batteries (in household quantities), water and oil based paints and tins, gas cylinders and fire extinguishers, conventional tube and compact fluorescent light globes, smoke detectors, motor and cooking oils.

These **problem wastes** can be extremely hazardous if placed into kerbside wheelie bins so we ask you dispose of these correctly at the Byron Resource Recovery Centre. For smaller problem waste items, head to the Council website to find the closest specialty **community recycling station** to you.
